ELIGIBILITY:

All contestants must be committed to adhere to all the pageant requirements, qualifications and Rules & Regulations. You must be a naturally born female with a beautiful face and a balance of height and weight.

You must be in excellent physical and mental health condition, a good moral character.

AGE REQUIREMENTS:

All "Miss" Pageants: 17 years old and up and not currently married.

All "Mrs." Pageants: 23 years old and up, married, divorced, separated or married to a spouse whose Ancestry/Ethnicity is the same as the contestant is applying for. Or Single with children

All "Miss Teen" Pageants: 13–17 years old by Pageant Night, never married and do not have any children.

ANCESTRY ELIGIBILITY REQUIREMENTS:

ASIA PAGEANTS – 20% ANCESTRY / LATINA PAGEANTS – 20% ANCESTRY / EUROPE PAGEANTS – NONE

DELEGATES RULES & REGULATIONS

DELEGATE'S REQUIREMENTS:

- Pageant Tickets:**
Each delegate must sell a minimum of 30 tickets, regardless of which price level. Delegates residing outside of California are exempt. Tickets are non-refundable and non-exchangeable.
- Souvenir Program Magazine:**
Each delegate must provide a minimum of THREE (3) FULL PAGE ADS in the Souvenir Program. Delegates residing outside California must provide a minimum of Five (5) Full Page ads in the Souvenir Program. *All content in the souvenir program, changes and placement is subject to approval and changes by Virgelia Productions, Inc. Changes to the advertisements may be made at any time by Virgelia Productions, Inc. with or without notice. Full payment and artwork must be received upon submission of advertisements. All ad content is due 30 days before the pageant. Late submissions will be charged a late fee as determined by Virgelia Productions, Inc. in its sole discretion.*
- Virgelia Productions, Inc. reserves the right, in its sole and unfettered discretion, to reject any Applications from a prospective applicant and to eliminate any delegate from the pageant at any time for any violation of the Rules and Regulations. Decisions of Virgelia Productions Inc. are final and not subject to appeal.
- All Delegates must provide a 120 words biography/resume. This is due 60 days before Pageant Night.
- All payments submitted for advertisements, sponsorships, entrance fees, donations, tickets, merchandises and miscellaneous items are non-refundable.
- Delegates are responsible for their own transportation, accommodations, hair and make-up artists at all times.
- On the day of the pageant: If you choose to bring assistants/chaperone/ hair-makeup artists inside the dressing room, there will be a charge of \$60.00 per person.
- Virgelia Productions, Inc. is not responsible for any lost, stolen or damaged properties of the delegates, your friends, and your families on any of the activities and on pageant day.
- On Pageant Day a Title Holder and Runners-up are chosen. All gift prizes and or scholarships are awarded subject to complete fulfillment of the winner's obligations during their respective twelve (12) month reigns (unless otherwise modified by Virgelia Productions, Inc.) Title Holders will receive: (i) a combination of scholarships and gift prizes (ii) a Majestic Crown and Sash and (iii) a Queen's Bouquet. All Runners-up will receive a sash or bouquet. Virgelia Productions, Inc. reserves the right to distribute the prizes at any time within twelve (12) months from Pageant Night. All prizes/gifts are provided to Virgelia Productions, Inc. by sponsors of the pageant and are subject to any conditions and restrictions imposed by such sponsors. If any sponsor elects, in their sole discretion to cancel or modify the prizes/gifts they have agreed to provide, then the prizes/gifts will be so cancelled or modified without any given notice. Virgelia Productions, Inc., including its employees, sponsors and agents, shall not be held responsible or liable for modified or cancelled prizes/gifts or any other actions by the sponsors or the grantor of these prizes. Taxes on prizes/gifts are the recipient's sole responsibility. All Title Holders must agree to the terms and conditions of the Title Holders Agreement, including mandatory attendance at a minimum of 2 events a month or 24 events total during their respective reigns. These events are assigned and provided by Virgelia Productions, Inc. Title Holders/Queen and Runners-up must attend all special appearances requested by Virgelia Productions, Inc. and must be on time on specific requests. Failure to comply or attend (30) special appearances will result into a dethronement. If at any time during her reign the queen is unable to fully perform her duties or fails to attend four (4) events during the title holder's reign, she is subject to dethronement. Should the Queen be dethroned or if she relinquishes her title before the end of her reign, all prizes, including crown, sash and trophy must be returned to Virgelia Productions, Inc. within 10 days in the same condition it was given to her. If a Title Holder is dethroned or chooses not to continue her reign, all prizes, including crown, sash and trophy, must be immediately returned in the same condition as it was when received. If any Delegate or Title Holders disparages, defames, libels, slanders or interferes with the pageants, Virgelia Villegas, Virgelia Productions, Inc., including its employees and agents, any sponsors, contractors, any judge, advertisers, committee members or any volunteers, then such delegate shall be eliminated from the pageant or dethroned and stripped of her title, gifts and prizes, as the case may be. Delegates are required to sign the Hold Harmless Agreement.
